Qualifying Applicants

Criteria:

- Will graduate from a secondary school with a Dogwood Diploma
- Are Canadian citizens or Permanent Residents
- Demonstrate a need for financial assistance
- Will be pursuing full time studies in an approved public Canadian post-secondary program in the creative sector
- Have been actively enrolled in an Arts Umbrella program for a minimum of six months

We understand that some students plan to take a "gap year" before pursuing post-secondary studies for varying reasons (i.e. work to raise funds or travel). In this scenario, you are still eligible to apply for the scholarship as long as you meet the following criteria:

- The gap year does not exceed the length of one academic year (i.e. September to August)
- The student can still provide proof of enrollment at their chosen public Canadian post-secondary institution
- The student can provide their reasoning for the gap year in their written statement
- Funds from the scholarship will be used towards supporting the student's time while enrolled in a program and actively taking classes

Application Process & Requirements

Application Deadline – EOD Monday, April 22, 2024

To apply for this scholarship program students must complete the attached form, which includes a written statement and budget. In addition, applicants must provide the following:

- Two references, one of which must be an Arts Umbrella faculty member. Family members are not eligible references. Each reference must complete a Creative Launchpad Reference Form and **email it directly** to Argel Monte de Ramos - Coordinator, Community Programs, Surrey amontederamos@artsumbrella.com
 - **Please Note:** completed reference forms must not be given to the applying student to submit
- Documentation of acceptance in chosen post-secondary program
- Shortlisted candidates may be required to participate in an interview with the selection committee

Program Eligibility

Maintaining Eligibility

If successful in receiving the Creative Launchpad Scholarship Award, the recipient will be expected to complete a report at the end of each academic year to request a renewal for the upcoming year. In order to maintain eligibility, recipients will be expected to remain in good academic standing as defined by their institution, pursue full-time studies each semester (unless less than a full-time course load is needed for the last semester before graduation), and show a responsible use of scholarship funds through a reasonable application of their proposed budget.
